I'm sure that you remember the email below from March 25 concerning allegations that ASSANGE had been followed by (b)(3) since you had to meet with the NSU because of them. This has come back up in the following way:

Army CID is in possession of chat logs where the person chatting identifies himself as "Nathaniel Frank." "Frank" states to another person on the chat that,

"On Thursday, March 18, 2010, I took the 2:15 flight out of Reykjavik to Copenhagen-on the way to speak at the SKUP investigative journalism

Conference in Norway. After receiving a tip, we obtained airline records for the flight concerned. (b)(3)

(b)(3)

CID believes that "Nathaniel Frank" in the chat log is in reality Julian ASSANGE. There is a minority opinion that "Frank" could be a Wikileaks associate, (b)(6); (b)(7)(C) Based on what "Nathaniel Frank" said in the chat log above and our point # 2 below, it seems that "Nathaniel Frank" is indeed Julian ASSANGE.

1- Do you have anything that corroborates that it was indeed ASSANGE who said that people followed HIM to a conference in Norway?

2- Do you have any contacts or any possible way to obtain the airline records (manifest) which shows everyone who was on the March 18, 2:15 flight out of Reykjavik to Copenhagen? If so, this would greatly assist in determining if ASSANGE and/or (b)(6); (b)(7)(C) were on that flight. This is important because "Nathaniel Frank" (whoever he is) goes on to give other relevant information in the chat logs concerning the SUBJECT of the investigation.

Thanks for whatever assistance you may be able to provide.
